Dale Morrissey, CEO, is celebrating 40 years with DSC. Dale began his career as Associate Director in March 1979 before moving onto the Director of Vocational in 1980, and then to COO/Associate Executive Director in 1981. He has served in his current role since 1987.

Dale has led the agency in maximizing the ways in which we serve children and adults with developmental and intellectual disabilities and their families in our community. His lasting impact is significant, as the agency has grown from serving 350 people with a \$3.2 million budget when he began as CEO to serving approximately 1,100 today with a \$13 million budget. DSC has been a member of our state association, IARF, for decades where Dale has held leadership roles on the Board of Directors and has worked tirelessly for people with disabilities throughout the state of Illinois through legislative changes and improvements.

While Dale's departure will be deeply felt by DSC, the organization will continue its good work under the leadership of Danielle Matthews who has worked with Dale for the past 11 years as the CEO/Executive VP of Support Services. Dale will not be a stranger to DSC during his next phase of life. He will continue to be actively involved in with DSC fundraisers.

Dale lives in Champaign with his wife, Susie, to whom he has been married for 41 years. They have two children, Mark and Michelle. Mark and his wife, Nicole, have two children, Shea and Piper to whom Dale and Susie are gushing grandparents! In his spare time, Dale enjoys being with his family and friends, exercising, playing golf, and spending time outside. His is passionate about our community, has been a Rotarian with Champaign Rotary for 32 years and has served on area boards and search committees.

A Message from Chief Executive Officer, Dale Morrissey...

Welcome to spring! After the long winter, it is nice to see longer days and warmer temperatures! While we are just entering the season of spring, we are several months into our 2019 advocacy efforts with the State of Illinois.

With the start of 2019, the 101st General Assembly for the State of Illinois also began and our continued efforts for the Direct Service Professional (DSP) wage increase. While we realized some success in last year's General Assembly, we still have progress to ensure all DSPs earn a livable wage.

House Bill 2148, provides that the "Department of Human Services shall establish reimbursement rates that build toward livable wages for front-line personnel." This legislation has been the cornerstone of IARFs (Illinois Association of Rehabilitation Facilities) advocacy efforts for the past three years. This legislation recognizes that as the state of Illinois minimum wage increases that wages for DSPs continue to increase above the minimum wage to retain the commitment to front-line personnel in direct service careers to earn a livable wage.

The statewide staff shortage continues to remain a central issue for DSC and all other intellectual and developmental disabilities providers throughout the state. Our efforts will not wane, as this is crucial for the people we serve.
